- 1. Committee Chair Decker opened the Budget & Finance Committee meeting at approximately 9:00 a.m. The Deputy Executive Director (DED) reported that the public meeting of the Budget & Finance Committee had been duly noticed in accordance with the Authority's Freedom of Information Regulations, read the Statement of Notice, and called the roll.
- 2. Committee Chair Decker called for a motion to accept the Budget & Finance Committee Minutes from February 20, 2019. Commissioner Smith made a motion, Commissioner Ford seconded, and the Committee Minutes were accepted.

3. Discussion Items:

• Pension and OPEB Valuation Review

The Chief Financial Officer (CFO) introduced Dave Boomershine from Boomershine Consulting to discuss the Authority's 2018 Pension Plan valuation. Mr. Boomershine discussed and highlighted the following:

- Recent History
- Demographics
- Assets
- Market Value Changes
- Valuation Assumptions
- Total Funded Status
- Total Recommended Contributions
- Conclusions
- GASB Changes
- Future Direction

Mr. Boomershine advised the pension plan has become a more "mature" plan as the number of retirees now exceeds the number of active members at the Authority. The CFO noted 121 of vested benefit members are not retirees. Mr. Boomershine advised the market value gain will be recognized over 5 years and there has been a slight actuarial value gain for investments including 15.1% increase in 2017 for investment return. Mr. Boomershine advised that outflow of expenses exceeding income is a sign of plan maturity. Mr. Boomershine advised after assumption changes the funded ratio remains the same as 2017 at 85% funded and continues to remain healthy. Mr. Boomershine noted annual contributions have increased, but decreased as a percentage of payroll to below 20%. The CFO advised for the future, staff will work with the consultant to evaluate using additional resources to de-risk plan liabilities and costs. Mr. Boomershine also discussed the Authority's OPEB Benefits actuarial review noting that the 59 percent funded ratio far exceeds the national average of 10 percent. Mr. Boomershine noted the importance of how the Authority's funding of the Annual Required Contribution enables the usage of a discount rate basis of 7.25% to reduce annual cost and lower liability. Mr. Boomershine also advised the potential impact of accounting and how Bond Rating Agencies view funding plans with a higher discount rate. Mr. Boomershine advised to continue additional contributions as able until 80% funding level is attained and continuing to manage healthcare experience.

• 2018 Investment Review

The CFO introduced Jim Dugan and Keith Stone from Brown Advisory to discuss the Authority's 2018 Investment Review. The following information was discussed:

- Executive Summary
- DRBA Employees' Retirement Plan and OPEB Trust
- Private Equity and Real Estate Investments
- DRBA Authority Funds
- The Big Picture: Our Investment Outlook

Mr. Dugan advised annual returns in 2018 were negative for just the second time in the last 10 years, but have rebalanced through the year as stocks rose again during the market decline. Mr. Dugan advised the Authority funds have maintained an elevated level of short-term securities and cash in the general fund to support capital improvement projects. Mr. Dugan advised equities turned negative in 2018, but noted a significant rebound in stocks in early 2019. Mr. Dugan advised the investment earnings for 2018 were -\$8.1 million due to declines in both the equity and fixed income markets. However, the rebound in the markets generated investment earnings of \$15.1 million through February 2019. Mr. Dugan noted the retirement plan has grown by \$78.3 million including total of contributions and withdrawals. Private Equity, real estate program and income generation have been the main drivers for high portfolio performance. Mr. Stone discussed the change in the investment policy statement to include an allocation to alternatives including private equity, private real estate and commodities. Mr. Stone advised the reason for inclusion was for additional diversification and potential for higher returns and noted the program continues to be built out slowly. Mr. Stone noted the importance of continuing to invest in private equity and the thought of another near recession has been concerned when building the portfolio.

• Moody's Investor's Service Recent Publication

The CFO discussed the January 2019 publication from Moody's Investor Service regarding the veto of the Authority's first proposed toll increase discussing the negative risks related to credit rating. The CFO noted both Moody's and S&P have been notified of the revised and approved toll structure.

• IRS Rebate- 2008 Issuance Variable Rate Bonds

The CFO informed the Committee of a \$140,000 payment that has been made to the IRS relating to positive arbitrage earnings on the 2008 variable rate bonds.

• Food Distribution at Cape May-Lewes Ferry

The CFO discussed a request for proposal process (RFP) for obtaining a qualified food vendor to serve as the primary supplier of food products intended for resale to the public at the Ferry. The CFO advised the proposal process would include developing a request for proposal asking for prices based on margins, allow for alternate products, and focus on quality of food products being offered. The CFO noted local vendors have been identified in Cape May and Lewes areas. The CFO recommended to the Committee to add these, as well as any additionally identified vendors, to the over25 resolution for the April meeting. The CFO noted that he had provided this information to Commissioner Bennett, who was unable to attend today's meeting, and received feedback and support for working with local vendors and further endorsed the procurement plan.

4. Due to Committee Chair Decker leaving the room, Commissioner Smith requested an Executive Session closed to the public to discuss matters of a confidential nature. A motion was made by Commissioner Ford, seconded by Commissioner Smith, and the Session was closed.

Delaware Aviation Economic Impact study is performed every 5 years by DelDOT and State of Delaware. The resulting economic impact report is used primarily to aid local municipalities and airport managers around the state of Delaware. It provides statewide airport spending information, direct/induced employment, and measures overall airport economic activity to help airport decision-makers with tools to defend the airport. It also measures state and local taxes as a measure of what the airports contribute back to the community.

In 2016, the state of New Jersey performed a similar assessment of airports economic impact.

Copies of the Delaware Report and information for Cape May and Millville Airports from the New Jersey report were made available to the Commissioners.

- 1. Committee Vice-Chair Ransome opened the Projects Committee meeting at 11:40 a.m.
- 2. Committee Vice-Chair Ransome called for a motion to accept the Projects Committee Minutes from February 20, 2019. Commissioner Lathern made a motion, Commissioner McCann seconded, and the Committee Minutes were accepted.

3. Contract Close-Out Actions:

• Contract No. DMB-16-01 Towing Services for I-295 SB Reconstruction

While I-295 was restricted to two lanes during the recent construction, DRBA paid a towing contractor to be on call during the DRBA's non-working hours to quickly clear accidents. The vendor was Nicks Auto Repair LLC of Penns Grove, NJ with a final cost of \$194,650.

Committee Vice-Chair Ransome called for a motion, Commissioner Lathem made a motion, seconded by Commissioner McCann and the Projects Committee concurred with the recommendation and authorized the close-out actions to be presented to the full board at the March meeting later today.

4. Contractor Payment Review:

The COO reviewed for the Committee the monthly construction contractor payments to be made for the work completed through February 2019. DRBA had 6 payments totaling approximately \$1.6 million for projects at the bridge, ferry and four airports.

4. Discussion Items:

CRODA Update

Croda reimbursed the Delaware River and Bay (DRBA) for all losses resulting from the Delaware Memorial Bridge being shut down in November 2018. As of now, ethylene oxide is not being manufactured at the plant. Croda is conducting their own safety review and then requires regulatory approval from Delaware's Department of Natural Resources and Environmental Control before they can restart the reactor. Ethylene oxide is being stored there as it has been since 1940's.

The DRBA is planning over the next twelve months another table top exercise with Croda officials, Town Hall meeting with DRBA employees plus two employee drills; one to rehearse sheltering in place and one evacuating to the airport.

I-295 Construction Update

After almost three years of construction, all lanes are moving again on I-295. The major task remaining is the final 2 inches of blacktop to be layered onto the roadway. Due to the weather, this has been delayed. The final paving will be done at night, but must wait until temperatures exceed 50 degrees around the clock. The work will take about two weeks.

• Large Ship Passing Under the Bridge

In March 2018 ship Zhen Hua 16 passed under the bridge, carrying tall cranes, at low tide close to midnight, clearing the bottom of the bridge by about 5 ½ feet. As a precaution, the bridge was closed for about 20 minutes. This year's ship is the Zhen Hua 25, currently anchored off Cape Henlopen, where the cranes are being lowered. This vertical to horizontal positon takes four full days. Preparation with the Coast Guard, the shipper, the port, river pilots and the Delaware River and Bay Authority is being conducted. This passing will occur twice with a northbound and southbound passage.

The air gap sensor that was put in place for last year's transit, measures the exact distance between the bottom of the bridge and the water's surface, has supplied a year's worth of actual tidal data.

From the previous passage, it was determined by the DRBA's engineering department, the ship can only pass during low tide. With maximum bridge load, bumper to bumper traffic the entire length, the bridge can sag as much as 5 feet. With this year's clearance estimated at 4 and 4.5 feet at low tide, the need is to eliminate any possibility of maximum load conditions, by closing the bridge to traffic.

Unless the weather changes, the northbound passage will occur Monday, March 25, 2019 at about 11 pm. Southbound will occur the following Tuesday, April 2, 2019 at 5:00 am low tide.

Commissioner Lathem inquired of alternative routes if the bridge is closed again to which the Chief Operations Officer explained that Colonel Arroyo is working on them and it will be presented at a future meeting.

5. With no further business to discuss, Committee Co-Chair Ransome made a motion to adjourn, Commissioner Lathem seconded, and the Projects Committee adjourned at 11:47 am.
